All information has been provided and fees are enclosed. I understand that if the player withdraws from the Kick Start Soccer program for any reason that I will not receive a refund. I hereby authorize the player to be transported by licensed ambulance and treated by a licensed physician or hospital in case of a medical emergency.

RELEASE OF LIABILITY / UNDERSTANDING OF RISK

IN CONSIDERATION OF my child/ward/myself, being allowed to participate in any way in the related events and activities of the Sandpoint Soccer Association, the undersigned acknowledges, appreciates, and agrees that: The risk of injury to my child or myself from the activities involved in the programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

1) FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and I knowingly and voluntarily WAIVE any and all claims I may have against Sandpoint Soccer Association, and RELEASE Sandpoint Soccer Association from said claims, EVEN IF ARISING FROM THE NEGLIGENCE OF Sandpoint Soccer Association or others associated with it, and assume full responsibility for my child's or my own participation; and,

2) I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's or my own readiness for participation and/or in the program itself, I will remove my child or me from the participation and bring such attention of the nearest official immediately; and,

3) I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Sandpoint Soccer Association; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my child's or my own involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

4) I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

5) I verify that to the best of my knowledge, the physical condition and fitness of the participant (my child/ward/myself) are adequate to safely participate in this activity.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. I UNDERSTAND THE SERIOUSNESS OF THE RISKS INVOLVED IN PARTICIPATING IN THIS PROGRAM, THE RESPONSIBILITIES FOR ADHERING TO RULES AND REGULATION, AND ACCEPT THEM ON BEHALF OF MY CHILD/WARD OR AS A PARTICIPANT.
